



## 2020-2021 BKHS REENROLLMENT

**Complete and submit the online Reenrollment Form in the FACTS/Renweb Family Portal.**

- **Login to your FACTS/Renweb Family Portal and Click on the Apply/Enroll on the left menu then Enrollment/Reenrollment.**
- **If you are divorced, please set up separate households on the form. We must have a copy of the custody agreement on file for the welfare of your student. The information is strictly confidential.**

**While you are completing the Reenrollment Form you will be directed at one point to FACTS Tuition to select a new tuition payment plan for the 2020-21 school year. You can select from the following payment plans:**

- **Annual payment** - One full payment through FACTS –tuition balance, iPad lease fee and graduation fee (if applicable) by **JUNE 1**  
There is not a FACTS enrollment fee for this option. Credit cards will be accepted with no fee for annual payments ONLY.
- **Semi-Annual payment** - 2 payments through FACTS – tuition payment, iPad, program, facility fee and graduation fee (if applicable)  
Payments due the 5th or the 20th of May, 2020 and November, 2020  
FACTS annual enrollment fee for this plan is \$10.00 per family
- **10 monthly payments** - 10 payments through FACTS – tuition payment, iPad, program, facility fee and graduation fee (if applicable)  
Payments due on the 5th or the 20th of the month - May 2020 through February 2021  
FACTS annual enrollment fee for this plan is \$38.00 per family
- **11 monthly payments** 11 payments through FACTS - – tuition payment, iPad, program, facility fee and graduation fee (if applicable)  
Payments due on the 5th or the 20th of the month – April 2020 through February 2021  
FACTS annual enrollment fee for this plan is \$38.00 per family

**Please be sure to hit the "Review and Submit Form" when finished. Once you submit the form you will be prompted to pay the \$425.00 registration fee via ACH (your bank account) or credit card. You will receive an email confirming you submitted the form.**

Please note: *Applications received after the Friday, March 6 deadline will incur a late fee as follows:*

- **\$100 (March 7 - May 31)**
- **\$200 (June 1 - July 31)**
- **\$300 (After July 31)**

**\*\*Student course selections may be delayed if any of the above steps have not been completed.**
